INSTITUTE'S BRANCHES

KEY FACTS

- International Law Institute was founded in Moscow in 1992. During its 20-year existence, the Institute became one of the major independent institutions of higher education specializing in providing legal education.
- Till 2005 the Institute was included into the system of higher education of the Ministry of Justice of the Russian Federation. Later its legal status was changed and it became an independent higher professional educational institution. The Institute enjoys a solid reputation for the quality of its education and is certified by the Ministry of Education and Science of the Russian Federation that recognizes the quality of the Institute's academic programs, considerable scientific work and broad research activities, thus allowing the Institute to award state-recognized degrees. The Institute offers four-year Bachelor's degrees, two-year Master's degree studies, Post graduate programs, undergraduate programs and continuing education courses.
- Initially based in Moscow, the Institute rapidly established a wide range of branches located in various regions of Russia, including the biggest cities such as Astrakhan, Smolensk, Nizhny Novgorod, Tula and 7 others. Over 16 thousand students study at 11 branches. During the years of its activities the Institute created modern material, teaching and training facilities and formed professional teaching staff. In most of the Institute's branches training is conducted in buildings and premises owned by the Institute where rooms and laboratories are equipped with all the necessary facilities. The staff and students of the Institute's branches actively participate in political, social and cultural life of their regions.





- Over 20 thousand specialists with higher legal education and more than 3 thousand those with secondary professional education have graduated from the Institute. Our graduates work successfully in the bodies and institutions of the Ministry of Justice, Prosecutor General's Office and Ministry of the Interior, courts of different levels and other state and administrative organizations, business structures both in Russia and abroad.
- At present the Institute's academic teaching staff is able to solve the most complicated tasks at a high professional level. Over 780 people including 437 lecturers and professors are employed at the Moscow head Institute and at the Institute's branches. The level of staffing with lecturers having scientific degrees in core (law) subjects reaches 80%. Doctors and Professors in core sciences give to 14% of the total limit of lectures and seminars while in-service lecturers give over 60% of classes.
- Practitioners like heads and leading staff of the federal and regional law enforcement agencies, courts and other organizations are also invited to deliver lectures and hold seminars.

EDUCATION

The Law Faculty's strong point is focusing both on fundamental law disciplines and specialized courses holding, and practical courses. This combination is the strength of the faculty which prepares its highly qualified graduates to successfully meet the demands of the market.

In 2009 the Institute launched training for a Master's degree and at present this training is conducted in three specialized programs. The first graduation of Masters was in 2012 with about 300 future Masters studying in the Institute at present.

Post graduate training has been carried out since 2001 in 4 fields. In 2008 the Joint Dissertation Council began its work at the Institute. At present theses are prepared in 2 scientific specialties. During these years the Council has approved theses of 41 candidates and post-graduates including 14 Institute's graduates.



FACULTY OF MANAGEMENT / STATE AND MUNICIPAL MANAGEMENT



In 2004 the Institute introduced a new educational course "Management of the organization". This specialty is divided into three specializations so that students could choose the one according to their future place of work. In 2012 one more new specialty, "State and municipal management", was introduced.

FACULTY OF ADDITIONAL PROFESSIONAL EDUCATION

In 1999 the faculty of additional professional education was set up. Since then over 12 thousand attendees from the Ministry of Justice; the Federal Customs Service; the Federal services of court enforcement officers; State registration, cadastre and cartography; court departments of the constituent entities of the Russian Federation; EMERCOM offices; Federal state unitary enterprise "Russian television and broadcasting network"; regional funds of staff training and other state, municipal and commercial structures have improved their qualification and got professional

FACULTY OF EXTERNSHIP AND DISTANCE LEARNING

New information technologies have been actively introduced in the Institute during the whole period of its existence. In 2004 the Center of Externship and Distance Learning was added to the Institute's structure. The use of modern information technologies improved the quality of training, gave the possibility to resort to active methods of teaching, to increase its creative and intellectual components, provided perseverance and continuity of education. Technologies and methods that have been developed and introduced let students use a wide range of information resources. Each student has an unlimited individual access to the electronic library system containing all reference materials and literature on academic subjects he or she is studying.

COLLEGE OF LAW

College of Law of International Law Institute was founded in 2000 and provides a secondary professional legal education. The college offers courses between 2 and 4 years (depending on student's level of education) which are based on a rigorous academic program combined with opportunities to train practical skills in legal profession.

RESEARCH

- The academic teaching staffcarries out significant scientific and research work. Since 2001 the Institute has been publishing scientific information journal "Bulletin of the International Law Institute". The network of law clinics of the Institute and its branches help needy and other people to receive necessary information and legal aid in the sphere of law, protection of citizens' rights, taxation and others. Participation of students and professors in the work of such clinics ensures practical orientation in training and formation of professional competence as required by FSES (FGOS).
- Students' scientific societies are very active in the Institute and its branches. Some of their members are awarded grants of the President of the Russian Federation, the Ministry of Justice of the Russian Federation, the Moscow Government and governments of other regions of the Russian Federation, some are winners and awardees of various competitions both international and organized by the Ministry of Justice of Russia, some are holders of grants of the regional Governments "Leader in education 2004, 2005, 2006" and so on.
- The students not only study fundamental theoretical subjects but also undergo practical training in the RF Federation Council, the State Duma, in the regional bodies of legislative and executive power, structural bodies of the Ministry of Justice of the Russian Federation, the Supreme Court, the Supreme Arbitration Court, prosecutor's offices, the Bar, notaries system, regional municipal courts, big banking and business structures.



CIVIL LAW SCIENTIFIC AND RESEARCH LABORATORY





Civil Law Scientific and Research Laboratory named after D.I. Meyer was founded in 2008. The Laboratory is both carrying on a vast cultural and educational investigation as well as scientific and practice work and implements its research projects.

The Laboratory's mission is creation of special research field and cultural environment for legal science development and upbringing of young leaders who possess special competence and readiness for active actions and decisions. Laboratory's projects are directed to changing legal education quality and forming common cultural and professional competencies.

INTERNATIONAL COOPERATION
